

# Livestock Dates & Requirements

~ Final Fair Enrollment for 2025: Monday, May 5, 2025

- ~ All 4-Hers must have paid the annual \$15.00 member fee, \$10.00 admin fee, and \$8.00 species fee (FFA youth must pay the species fee to the advisor)  
No one is allowed to participate unless they are a registered member of 4-H or FFA by the required time.
- ~ All enrollments for animals are due one week before initial weigh-in. Sheep, Turkeys, Rabbits, Goats, Horse, & Dog are due May 5, 2025.
  - ~ Horse project record books & Show entry forms due July 28, 2025 by 4 p.m.
- ~ All livestock market & breeding, Cloverbud animal memory books, and dog project record books due by July 30, 2025 by 4 p.m. (dairy must include palpation verification & bangs vaccination receipt in record book & turkey must turn in tri-fold)
- ~ All 4-H youth doing livestock (including dog & horse) must do one presentation per registered species. FFA optional
  - ~ There will be two dates for each species and one make up day in June (not part of contest)

## BEEF

Enrollment Deadline: Friday, February 28, 2025  
Livestock Agreements & Bills of Sale or Idaho Brand Inspection: Due by February 28, 2025  
Beg. Weigh-in Date: Saturday, March 8, 2025, Burley Livestock Auction Yard 7-8:30 a.m.  
Beg. Weigh-in Requirements: Maximum weight 1,000 lbs.  
Steer will be halter broke & given a halter score  
Days on Feed: 157  
Fair Weigh-in Requirements: Minimum weight 1,100 lbs., no maximum, ADG 2.25 lbs

## SWINE

Enrollment Deadline: Thursday, April 10, 2025  
Livestock Agreements & Cool Forms/Bills of Sale: Due by April 10, 2025  
Beg. Weigh-in Date: Thursday, April 17, 2025, Fairgrounds 6-7:30 p.m.  
Beg. Weigh-in Requirements: Maximum weight 125 lbs, minimum weight 40 lbs  
(suggested minimum of 80 lbs)  
Days on Feed: 118  
Fair Weigh-in requirements: Minimum 230 lbs. and Maximum 330 lbs.

## DAIRY

Enrollment Deadline: Tuesday, April 29, 2025  
Livestock Agreements & Bills of Sale/Idaho Brand Inspection: Due by April 29, 2025  
Beg. Weigh-in Date: Tuesday, May 6, 2025 Fairgrounds 6-7:30 p.m.  
Beg. Weigh-in Requirements: All heifers must be Dec. 2024 calves  
Days on Feed: 97  
Fair Weigh-in requirements: no minimum, ADG: Holsteins 1.40 lbs., Jersey 1.05 lbs. & Crossbred 1.20 lbs.

## SHEEP

Enrollment Deadline: Monday, May 5, 2025  
Livestock Agreements & Cool Forms/Bills of Sale: Due by May 5, 2025  
Beg. Weigh-in Date: Tuesday, May 13, 2025, Fairgrounds 6:30-7:30 p.m.  
Beg. Weigh-in Requirements: No minimum or maximum (suggested 70-100 lbs, scrapie tags must be in place for all market sheep projects)  
Days on Feed: 91  
Fair Weigh-in Requirements: Minimum 110 lbs., no maximum, ADG .40 lbs.

## TURKEY

Enrollment Deadline: Monday, May 5, 2025  
Livestock Agreements & Cool Form/Bill of Sale: Due by June 4, 2025  
Beg. Weigh-in Date: Wednesday, June 11, 2025, Fairgrounds 6 - 7 p.m.  
Beg. Weigh-in Requirements: Baby Poults must be hatched between April 10- May 25 and it is recommended they weigh at least 8 lbs  
Days on Feed: 62  
Fair Weigh-in requirements:  
Toms - Minimum 23 lbs. and Maximum 35 lbs., Hens - Minimum 18 lbs. and Maximum 30 lbs.

## GOAT

Enrollment Date: Monday, May 5, 2025  
Livestock Agreements & Cool Form/Bill of Sale: Due by May 27, 2025  
Beg. Weigh-in Date: Tuesday, June 3, 2025, Sale Barn 6 - 7 p.m.  
Beg. Weigh-in Requirements: Must be born after Nov. 1, 2024, minimum weigh 35 lbs (scrapie tags must be in place for all market goat projects)  
Days on Feed: 69  
Fair Weigh-in Requirements: Minimum 60 lbs., Maximum 125 lbs., ADG .25 lbs

## RABBITS

Enrollment Deadline: Monday, May 5, 2025  
Livestock Agreements & Cool Form/Bill of Sale: Due by June 23, 2025  
Bunnies must be born after May 15, 2025  
Beg. Weigh-in Date: Monday, June 30, 2025, TBA  
Beg. Weigh-in Requirements: None  
Days on Feed: 42  
Fair Weigh-in Requirements: Pen of 3, each weighing 4lbs. 8 oz. - 6 lbs. 8 oz
