**ATHLETIC EVENT AGREEMENT**

This Agreement entered into between THE REGENTS OF THE UNIVERSITY OF CALIFORNIA VIA ITS RIVERSIDE CAMPUS and the UNIVERSITY OF IDAHO confirms the following stipulations:

1. The teams representing the above named institutions shall compete per the following:

**Sport: Women's Basketball**  
**Date: Wednesday, November 20, 2024**

**Event Site: UCR Student Recreation Center**  
**Game Time: TBD**

- 2. The contest shall be governed in all respects, including the eligibility of the participants, by the rules and regulations of the NCAA or any conference or association to which either or both of the parties may be affiliated.
- 3. Officials: The officials for this event shall be assigned by the **Big West Conference**
- 4. Guarantees and Financial Arrangements: **None**
- 5. Complimentary Tickets: The visiting team shall be allocated ~~-40-~~ complimentary tickets for this contest. Complimentary tickets will be administrated via a pass list, which will include the coach's and/or student-athlete's name, each guest's first and last name, and a guest signature line. Typed lists are preferred; however, legible hand written forms will be accepted. UCR can provide a blank complimentary ticket form upon request.
- 6. In the event that an institution shall cancel or fail to appear for the contest(s) specified in the Agreement (except by mutual agreement), the party so canceling or failing to appear, shall pay to the non-defaulting party the sum of **\$30,000** as liquidated damages for each such canceled game. Payment of liquidated damages shall be paid no later than thirty (30) days after the scheduled date for each canceled game. Cancellation or delay due to Acts of God (i.e. pandemics, earthquakes, etc.), acts of nature, labor strikes, utility outages, transportation interruptions, wars or acts of any governing regulatory body, including but not limited to NCAA or any governing athletic conference, or any other reason that would present a Force Majeure situation shall not be cause for liquidated damages to be paid.
- 7. Broadcast Rights: With the consent of the home institution, the visiting team may designate (1) radio station for broadcast to its home listening area with rights fees being waived. All other radio/ video rights and fees are the property of the home institution. Permission must be requested in writing to the home institution and the home institution shall respond in writing.
- 8. Other Arrangements: **UC Riverside to play at Idaho in the 2025-2026 season**
